RULES AND REGULATION OF THE ASSOCIATION

1. Name of the Association: "Alumni Association of Government Degree College, Rayachoty"

Address: D.No.38/105 – 11/2, Chittoor Road, Rayachoty -516269, Annamayya District, A.P

2. Membership:

a. Any person who was old student of **Government Degree College, Rayachoty**, male or female is eligible and who is desirous to become a member of the association, shall abide by the rules and rations of the association, in payment of Rs.100/- us membership lee per annum or Rs.500/-as a Life Member

b. any student who pay the annual subscription of Rs. 100/-during his study in the college can be considered as student member of the Association and he/she will automatically become member of the Association after passing out from the College, taking the subscription of Rs. 100/- paid during his/her studentship as the annual membership for the first year

3. Termination the membership: By Death or Resignation becoming of unsound mind, by not receiving the membership fee within the three months from the end of each financial year except in the case of life members. However executive committee may condone any member and readmit him/he fur membership provided such members pay all the arrears to the Association.

4. Meeting.

a. General Body: The association shall convince general Body meeting once in a year preferable in month of June all the maters connected with affairs of the association shall be discussed and decided in the meeting. The election of the office Barriers shall also be conducted in the meeting. The quorum of this meeting shall be more than half of the members on roll

b. Executive Committee: The Executive committee meeting shall be convened once in every six months or two times in a year giving at least 2 days advance notice to the members of the Executive Committee For any emergency purpose 24 hours prior written notice shall be given for convening the Executive Committee meeting The Executive Committee meeting shall be convened by the 3/5members the Executive members by themselves convene the meeting the quorum of the meeting shall be more than half of the members

c. Executive Committee or Governing Body the Executive Committee consists of a President, Vice President, Secretary, Joint Secretary, Treasurer and any Five (5) Executive members. The period of the committee will hold offices or a period of ONE YEAR

5. Power of the Governing Body

a. President:

The president shall preside overall entire meeting and review the president shall be the Ex-officio member who is the principle of Government Degree College, Rayachoty.

The President guides the activities off the association in popper manner. The president shall conduct both general body / Execute body meetings regularly the president has a costing vote if the quorum is not achieving the president will use costing vote and the resolution passed.

b. Vice President:

In the absence of the President, the Vice-President shall enjoy all powers and duties, which are entrusted to the President. He/ She will also help and assist the President in his/her work.

c. General Secretary:

- a) To sign on behalf of the Association, conduct its correspondence and to record the proceedings of the meetings.
- b) To summon and attend the meeting of the General Body.
- c) To call extraordinary general body meeting if requisitioned by at least 1/4th members of the General Body.


d. Joint Secretary:


In the absence of the General Secretary, the Secretary shall enjoy all powers and duties which are entrusted to the General Secretary. He/ She will also help and assist the General Secretary in his/her work.

e. Treasurer:

He/ She shall keep accounts of receipts and expenditure of the society and furnish necessary information to the Governing Body. He/ She will keep with him/her Rs. 2,000/- in cash and the balance amount will have to be deposited in a nationalized or schedule bank

f. **Executive members:** The remaining members shall assist the secretary for the welfare activities of the Association.

6. Bank Accounts, Books of Account and Audit of Accounts

a. The President shall open Bank Account jointly with the Secretary and the same shall be operated by the President along with the Secretary. The Executive Committee shall ensure that the proper Books of Account are maintained with respect to:

- i. All Income and Expenditure of the Association.
- ii. The Assets and Liabilities of the Association.

b. Financial Year means period of twelve months ending with 31st March of every year.

c. The Books of Account shall be kept in the office of the Association or at such other place as the Executive Committee thinks fit and safe. It shall be open for inspection during the college hours of the Association.

d. Financial Statements of the Association should be audited by an Auditor who is a member of ICAI and who will be appointed by the General Body. The Auditors should not be a member of Executive Committee.


e. The Treasurer shall be responsible for placing the Annual Accounts of the Association within three months of the closure of the financial year i.e., 30th June before the Executive Committee. The Association should place the records within a period not exceeding six months from the closure of financial year before the General Body Meeting with the Financial Statements together with Auditor's Report duly signed by the Auditor and the President, Secretary and Treasurer of the Association. Budget for the Receipts and Expenditure for the succeeding year shall also be placed before the General Body Meeting.

7. Legal Matters:


The association may sue or be sued in the name of the Secretary only. The Executive Committee shall appoint legal Adviser(s) from time to time.

The association shall be dissolved as per the provisions of Sec.24 of AP Societies Registration ACT/35 of 2001.


11. Alteration to bye-laws and regulations:


