## **MEMORANDUM OF UNDERSTANDING (MOU)**

**Between:**

**Government Degree College, Rayachoti, Annamayya Dist, A.P**

**And**

**Archana Nursing Home, Rayachoti, Annamayya Dist,A.P**

### **Preamble:**

This Memorandum of Understanding (MOU) is entered into on 27-07-2022, hereinafter referred to as the "Effective Date," between Government Degree College, Rayachoti (hereinafter referred to as the "College"), and Archana Nursing Home (hereinafter referred to as the "Hospital"), collectively referred to as the "Parties."

### **1. Purpose and Objectives:**

The Parties hereby agree to collaborate with the following objectives:

1.1. To provide college students with hands-on experience and practical knowledge in the field of healthcare and hospital management.

1.2. To deepen the understanding of medical procedures and hospital practices, including OP writing, proper use of hospital tables, sugar testing by glucometer, nebulization, injection loading, and ECG machine usage.

1.3. To facilitate knowledge exchange and learning between the academic and healthcare sectors.

### **2. Activities Under the Linkage:**

2.1. Archana Nursing Home agrees to offer short-term and long-term internships to eligible college students, during which students will work under the guidance of experienced healthcare professionals at the Hospital.

2.2. College students will actively participate in various aspects of hospital operations, including shadowing medical staff, learning about medical equipment, and assisting with relevant administrative tasks.



2.3. The Parties will organize joint workshops, seminars, and training sessions where Hospital experts can share their knowledge and expertise with college students.

**3. Duration:**

This MOU shall remain in effect from the Effective Date for an Initial period of three years, subject to mutual agreement for extension or modification.

**4. Terms and Conditions:**

The Parties agree to the following terms and conditions:

4.1. The specifics of internships, training programs, and educational sessions will be documented in separate agreements to be developed jointly by the Parties. These agreements will include details on selection criteria, duration, mentorship, evaluation, and any financial arrangements.

4.2. Both Parties agree to maintain confidentiality with respect to patient information and proprietary information shared during the course of the linkage.

**5. Termination:**

Either Party may terminate this MOU with written notice to the other Party, subject to a 60 days notice.

**6. Governing Law:**

This MOU shall be governed by and construed in accordance with the laws of state government of Andhra Pradesh.

**7. Entire Agreement:**

This MOU constitutes the entire agreement between the Parties and supersedes all prior understandings, representations, and agreements.
