Preamble

Amendments

Any amendments or changes to this MoU must be made in writing and signed by both Parties.

Termination

This MoU may be terminated by either Party with 30 days written notice.

Governing Law

This MoU will be governed by and construed in accordance with the laws of government of Andhra Pradesh.

This MoU constitutes the entire agreement between the Parties and supersedes all previous agreements and understandings, whether oral or written.
