**Background:**

**Agreement:**

2. **Roles and Responsibilities:**
  - o **Party A:**

  - o **Party B:**

**Duration:** This MoU will remain in effect for a period of three years from the date of signing unless terminated by either Party with prior written notice of 30 days.

**3. Terms and Conditions:**

- o The internships shall be unpaid unless otherwise agreed upon in writing between the parties.
- o Both parties shall maintain confidentiality regarding any proprietary or confidential information shared during the internship period.

**4. Evaluation:**

- o Party A and Party B will conduct periodic evaluations of the interns' performance and progress.
- o Feedback sessions will be organized to discuss the interns' achievements and areas for improvement.

- 5. Termination:** Either party may terminate an internship prematurely due to valid reasons such as non-performance or breach of terms, with prior notice and discussion.

**Miscellaneous:**

- This MOU constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior agreements and understandings.
- Any amendments or modifications to this MOU must be made in writing and signed by authorized representatives of both parties.
